Any information or instructions published by the Promoter about the Prize Draw on the participating websites form part of these Terms and Conditions.

The Promoter

1.This prize competition is being promoted by www.mobilephonesdirect.co.uk, www.affordablemobiles.co.uk and www.buymobiles.net – websites owned and operated by the AO Group of companies registered at 5A Parklands, Lostock, Bolton BL6 4SD (the Promoter/ AO/ Us/ Our/ We).

Promotion Period

2.The Prize Draw is open from 00.01 (GMT) on Monday 16th December 2024 until 23.59 (GMT) on Tuesday 21st January 2025 (the Promotion Period).

Prize

- 3. The Prize is a £500 voucher to spend on a Samsung device at Mobile Phones Direct (mobilephonesdirect.co.uk). The Prize is non-transferable and may not be substituted by the winner. Further Prize details are at paragraphs 8-9 below.
- 4. The prize can be redeemed against the upfront cost of a pay monthly new or upgrade contract. Eligible handsets must be from the Samsung manufacturer and available for sale during the redemption period.

Entry & Eligibility

- 5. Only individuals who have completed the register your interest form on the competition entry page are eligible to participate in the Prize draw.
- 6. Eligible participants are automatically entered into the Prize Draw by fully completing all required fields on the competition entry form during the Promotion Period.
- 7. Further to paragraph 5, to be eligible for the Prize you must also be a UK (excluding Northern Ireland) resident aged 18 or over (not a business or corporate entity). Employees or agents of the Promoter or any of its group companies or their families or households or anyone professionally connected will not be eligible for the Prize.

Winner Selection & Prize Fulfilment

The winners will be notified by a member of the AO team by email or telephone to let them know they have won (within 5 days of the end of the Promotion Period). The winner will have 14 days to accept the Prize by replying to the communication from AO.
- 9. In accepting the Prize, a winner will be deemed to have accepted and be bound by these Terms & Conditions. In the event that a winner fails to provide necessary details, is unreachable, is ineligible, fails to accept the Prize within the period specified at paragraph 7 above, or fails to comply with reasonable requests of AO for fulfilment purposes, the winner shall forfeit the Prize and it shall be awarded to a substitute winner, which shall be the next entry selected at random.
- 10. **Prize Voucher details:** The Prize is a £500 voucher to be redeemed on the websites listed at **paragraph 1** for purchases described at **paragraph 4**. Each winner will be provided with a unique voucher/code electronically via the email address provided at register-your-interest stage. The winner must follow the instructions in the email to redeem the prize voucher. **Important:** The voucher is single-use and can be redeemed on a basket totalling £501 or more. In the event the purchase is subsequently returned/cancelled by the winner, no replacement voucher will be issued however a refund will be issued for any additional spend by the winner over and above the value of the voucher.
